Note 1. Summary of Significant Accounting Policies

The Annual Expenditure Limitation Report (AELR) is presented on the basis of accounting prescribed by the *Uniform Expenditure Reporting System* (UERS), as required by Arizona Revised Statutes §41-1279.07. The AELR excludes expenditures, expenses, or deductions of certain revenues specified in the Arizona Constitution, Article IX, §20, from the total expenditures, expenses, or deductions reported in the fund financial statements.

In accordance with the UERS requirements, a note to the AELR is presented below for any exclusion claimed in part II and each subtraction or addition in the Reconciliation that cannot be traced directly to an amount reported in the fund financial statements. All references to financial statement amounts in the following notes refer to the Statement of Revenues, Expenditures, and Changes in Fund Balances for the Governmental Funds, Statement of Revenues, Expenses, and Changes in Net Position for the Proprietary Funds, Statement of Cash Flows for the Proprietary Funds, and the Statement of Changes in Fiduciary Net Position for the Fiduciary Funds.

Note 2. Debt Service Requirements

The exclusion claimed for debt service requirements in the Governmental Funds of \$3,344,995 consists of \$3,444,080 of expenditures classified as principal and \$148,360 classified as interest, less \$247,445 attributable to the Jail District for which total expenditures were subtracted on the Reconciliation. The exclusion for the Enterprise funds is \$130,000 of principal payments made in the Solar Field Fund.

Note 3. Dividends, Interest, and Gains on the Sale or Redemption of Investment Securities

The exclusion claimed for dividends, interest, and gains on the sale or redemption of investment securities of \$272,412 consists of investment income reported in the Governmental Funds of \$43,492 and interest on delinquent taxes expended of \$228,920, which was recorded as tax revenue.

Note 4. Trustee or Custodian

The exclusion claimed for trustee or custodian of \$250,200 in the Governmental Funds consists of contributions recorded as health expenditures by the County to the Arizona Health Care Cost Containment System for acute care, administrative cost contributions and uncompensated care contributions.

Note 5. Federal Grants & Aid, Amounts from the State of Arizona, & Highway User Revenues

The following schedule presents revenues from which exclusions have been claimed for federal grants and aid, amounts received from the State of Arizona, and highway user revenues in the Governmental Funds. The amounts excluded do not exceed expenditures of such revenues.

Note 6. Amounts from the State of Arizona

During fiscal year 2021 the County received \$720,171 from the State of Arizona for motor vehicle license tax reported as taxes in the Road Fund in the fund financial statements. Of this amount, \$0 was expended and is not included as part of the \$2,398,241 exclusion for amounts received from the State of Arizona. The remaining \$720,171 has been carried forward to future years. See also Note 10.

Note 7. Pensions and OPEB

The \$1,023,073 subtraction for pension and other post employment benefit (OPEB) expense consists of changes in the net pension and OPEB liabilities, changes in deferred outflows related to pensions and OPEB, and changes in deferred inflows related to pensions and OPEB, recognized in the current year in the enterprise funds. The \$858,221 addition for pension and OPEB contributions paid in the current year consists of the required pension and OPEB contributions made to the Arizona State Retirement System from the enterprise/internal service funds. The schedule below reconciles the net effect the subtraction and addition have on the expenditures subject to the limitation to the amounts reported on the statement of cash flows' net effect on cash:

Note 8. Separate Legal Entities

The subtraction of \$3,466,182 for separate legal entities established under Arizona Revised Statutes consists of the following expenditures included within the County's reporting entity but not included in the Economic Estimates Commission base limit calculations.

Note 9. Long Term Care Contributions

The subtraction for long-term care contributions withheld by the State Treasurer consists of transaction privilege taxes withheld by the State Treasurer to meet the County's share of long-term care costs that was reported as revenue and an offsetting expenditure in the County's Governmental Funds. Consequently, this expenditure has been subtracted on the Reconciliation.

Note 10. Carryforward Balances

Revenues that are constitutionally excludable that were not spent in the year of receipt may be accumulated and excluded in future years when spent. A summary of the revenue sources and the changes in their balances is shown in the table below:
