Our Office has recently completed a 24-month followup with the Arizona State Boxing Commission regarding the implementation status of the 21 audit recommendations (including sub-parts of the recommendations) presented in the performance audit report released in September 2000 (Auditor General Report No. 00-18). This audit also addressed boxing revenue collection responsibilities performed by the Arizona Department of Racing. As the attached grid indicates:

- 17 of the 21 recommendations have been implemented;
- 2 of the 21 recommendations are in the process of being implemented; and
- 2 of the 21 recommendations have not been implemented.

Unless otherwise directed by the Joint Legislative Audit Committee, this report concludes our follow-up work on the Agency's efforts to implement the recommendations resulting from the September 2000 performance audit.

The Executive Director stated that, because licensing requirements vary from state to state, the Commission will not establish reciprocal agreements with other states and will obtain all necessary documents from each licensee as outlined in recommendation #2.
2. For each boxer not licensed through a reciprocal agreement, the Arizona State Boxing Commission should ensure that it receives a copy of a current, thorough medical examination, including opthalmological examination, prior to licensure.	Implemented at 6 months
