Our Office has recently completed a 30-month followup of the Department of Agriculture—Pest Exclusion and Management Program regarding the implementation status of the 8 audit recommendations (including sub-parts of the recommendations) presented in the performance audit report released in September 2000 (Auditor General Report No. 00-13). As the attached grid indicates:

- 5 of the 8 recommendations have been implemented;
- 1 of the 8 recommendations is in the process of being implemented; and
- 2 of the 8 recommendations, both of which require legislative action, have not been implemented.

Unless otherwise directed by the Joint Legislative Audit Committee, this report concludes our follow-up work on the Department's efforts to implement the recommendations resulting from the September 2000 performance audit.
