Dear Senator Bennett and Representative Voss:

Our Office has recently completed a 6-month followup of the Department of Public Safety—Drug Abuse Resistance Education (D.A.R.E.) Program performance audit report released in February 2001 (Auditor General Report No. 01-03). The report recommended that the Department work with the Arizona Drug and Gang Policy Council to determine if its continued participation in the D.A.R.E. program was in the State's best interest. The Department's participation in the program primarily involved its administration of the Southwest Regional Training Center that provided training and technical assistance for D.A.R.E. programs in Arizona and the Southwest region. However, due to the elimination of federal grant funding for the regional training centers, DPS concluded its participation in the program as of September 1, 2001.

Because the Department will no longer be participating in the D.A.R.E. program, our Office will not continue to follow up with the Department of Public Safety on the status of this recommendation.

FINDING I: Department Should Work with the Drug and Gang Policy Council To Determine Its Future Involvement with D.A.R.E.

Not implemented	The Arizona Department of Public Safety (DPS) participates in the D.A.R.E. program through its administration of the D.A.R.E. Southwest Regional Training Center that provides training and technical assistance for D.A.R.E. programs in Arizona and the Southwest region. However, due to the elimination of federal grant funding for the regional training centers, DPS will onclude its participation as of September 1, 2001.
