Our Office has recently completed a 24-month followup of the Arizona Department of Veterans' Services regarding the implementation status of the 6 audit recommendations (including sub-parts of the recommendations) presented in the performance audit report released in August 2001 (Auditor General Report No. 01-16). As the attached grid indicates:

- 4 of the 6 recommendations have been implemented;
- 1 of the 6 recommendations is in the process of being implemented; and
- 1 recommendation has not been implemented.
