Our Office has recently completed a 6-month followup of the Department of Transportation, Motor Vehicle Division regarding the implementation status of the 2 audit recommendations (including sub-parts of the recommendations) presented in the sunset review report released in September 2004 (Auditor General Report No. 04-11). As the attached grid indicates:

- 1 recommendation has been implemented; and
- 1 recommendation requiring legislative action, has not been implemented.

Since the recommendation that has not yet been implemented requires legislative action, and unless otherwise directed by the Joint Legislative Audit Committee, this report concludes our follow-up work on the Department's efforts to implement the recommendations resulting from the September 2004 sunset review report.

Not Implemented	HB 2577 would have repealed A.R.S. §§28-449, 28-450, and 28-452, and amended other statutes in compliance with DPPA. This bill was introduced in the first regular session of the 47th Legislature in 2005, but was not heard.
