2. Provide a range of expected revenues for the next cycle of RTA Plan revenue projections, instead of only providing one scenario as in the past.

Chapter 4: Performance on Roadways Revealed Mixed Results

 Improve practices related to the preparation and reporting of five-year performance assessment reports by releasing the information on a more frequent basis.

Implementation in process

Performance assessment reporting is being improved through the new Performance Measure (PM) Dashboard the Pima Association of Governments (PAG) is developing. According to PAG, it will annually review and update available performance data for key metrics on its PM Dashboard as well as prepare summary sheets using data from the PM Dashboard for the 47 performance measures captured in its long-term 2045 Regional Mobility and Accessibility Plan (RMAP). PAG plans to update all data sets used in the PM Dashboard annually during July and August.

4. Capture roadway-related data and analyze performance against recently adopted Regional Mobility and Accessibility Plan targets.

Implementation in process

PAG is working on a comprehensive expansion of its data collection and the development of a PM dash-board for the 47 performance measures captured in the long-term 2045 RMAP as part of its efforts to implement the recently finalized federal performance measurement requirements. The expansion of performance data will use both modeled data and actual results from sources including, but not limited to, the National Highway Traffic Safety Administration's Fatality Analysis Reporting System, the Arizona Department of Transportation's (ADOT) Accident Location Identification Surveillance System, the National Bridge Inventory database, and the U.S. Census

		American Community Survey databases. Additionally, according to PAG, discussions are underway with ADOT about purchasing travel time data for all of Arizona.
		As previously mentioned, PAG is developing a new PM Dashboard that will capture and analyze data by comparing current performance and historic data to interim targets and long-term goals. We reviewed the in-progress PM Dashboard and found it to be robust, clear, informative, comprehensive, and easy to navigate. Moreover, the PM Dashboard will generate a one-page summary for each of the 47 performance measures established in PAG's long-term 2045 RMAP. Each summary lists the RMAP goals, observed values, an interim target, and sources of data, process, and update schedule.
5.	Continue to refine performance-based planning and measurement through an iterative approach adjusting measures and targets as needed to better achieve regional goals.	Implementation in process Along with the other efforts described in the explanations for Recommendations 3 and 4, PAG will compare observed performance with mid-term and long-term goals as part of its long-term 2045 RMAP update starting in 2018, with an anticipated completion in 2020.
