## Gila County Notes to Annual Expenditure Limitation Report Year ended June 30, 2016

#### Note 1 - Summary of significant accounting policies

The Annual Expenditure Limitation Report (AELR) is presented as prescribed by the Uniform Expenditure Reporting System (UERS), as required by Arizona Revised Statutes §41-1279.07. The AELR excludes expenditures, expenses, or deductions of certain revenues specified in the Arizona Constitution, Article IX, §20, from the total expenditures, expenses, or deductions reported in the fund financial statements.

In accordance with the UERS, a note to the AELR is presented below for any exclusion claimed on Part II and each subtraction or addition in the reconciliation that cannot be traced directly to an amount reported in the fund financial statements. All references to financial statement amounts in the following notes refer to the statement of revenues, expenditures, and changes in fund balances for the governmental funds; statement of revenues, expenses, and changes in fund net position for the proprietary funds; statement of cash flows for the proprietary funds; and the statement of changes in fiduciary net position for the fiduciary funds.

#### Note 2

The exclusion claimed for debt service requirements consists of principal retirement and interest expenditures in the governmental funds.

#### Note 3

The exclusion claimed for dividends, interest, and gains on the sale or redemption of investment securities of \$511,334 in the governmental funds includes investment earnings expended of \$163,588 and interest on delinquent taxes expended of \$347,746, which was recorded as tax revenue.

#### Note 4

The exclusion claimed for trustee or custodian in the governmental funds consists of \$1,413,200 in County contributions to the Arizona Health Care Cost Containment System for acute care, uncompensated care, and administrative costs; and in the fiduciary funds, the exclusion consists of \$95,002,492 in distributions to investment pool participants.

#### Note 5

The following schedule presents revenues from which exclusions have been claimed for federal grants and aid, highway user revenues, and amounts received for distribution to school districts in the governmental funds:

#### Note 6

The exclusion claimed for grants, aid, contributions, or gifts from a private agency, organization, or individual, except amounts received in lieu of taxes of \$322,378 in the governmental funds, consists of \$82 and \$322,296 in private donations and contributions in the General Fund and Community Services Fund, respectively.

#### Note 7

The \$1,508,622 exclusion claimed in the governmental funds for amounts accumulated for the purchase of land and the purchase or construction of buildings or improvements consists of highways and streets expenditures for new road construction and major road reconstruction projects made from the accumulation of sales tax revenues approved by the County voters and, therefore, is exempted from the expenditure limitation.

#### Note 8

The exclusion claimed for amounts received for distribution to school districts of \$2,774,752 consists of federal, state, and county revenues recorded as education expenditures for operating an accommodation school.

#### Note 9

The subtraction of \$1,396,304 for separate legal entities established under Arizona Revised Statutes consists of expenditures of special assessment districts included within the County's reporting entity, but not included in the Economic Estimates Commission base limit calculations, and are reported in the governmental funds category in the fund financial statements:

#### Note 10

The subtraction of long-term care contributions withheld by the State Treasurer consists of transaction privilege taxes withheld by the State Treasurer to meet the County's share of long-term care costs that were reported as a revenue and an offsetting expenditure in the County's governmental funds. Consequently, this expenditure has been subtracted on the reconciliation.

#### Note 11

The subtraction of \$159,399 for landfill closure and postclosure care costs consists of that portion of the total estimated liability reported as expenses in the current year but not yet paid in the enterprise funds.

### Note 12

The subtraction of \$7,482 for pension expense consists of the change in the net pension liability recognized in the current year in the enterprise funds. The addition of \$43,324 for pension contributions paid in the current year consists of the required pension contributions made to the Arizona State Retirement System from the enterprise funds.
