We have audited the accompanying Annual Budgeted Expenditure Limitation Report of Graham County Community College District for the year ended June 30, 2007. Note 1 - Summary of Significant Accounting Policies

The Annual Budgeted Expenditure Limitation Report (ABELR) is presented on the basis of accounting prescribed by the uniform expenditure reporting system (UERS), as required by Arizona Revised Statutes (A.R.S.) §41-1279.07, which excludes expenditures of certain revenues specified in the Arizona Constitution, Article IX, §21 from the total budgeted expenditures.

The information reported in both the ABELR and the financial statements is derived from the same underlying accounting data. However, the formats of the ABELR and the financial statements differ. The ABELR presents budgeted expenditures, exclusions, and amounts subject to the limitation by fund type as required by A.R.S. §41-1279.07. The financial statements present the net assets, changes in net assets, and cash flows in accordance with U.S. generally accepted accounting principles.

In accordance with the UERS requirements, a note to the ABELR is presented below for any exclusion reported in the Total column on Part II that cannot be traced directly to an amount reported in the annual financial statements.

Note 2 - Of the \$1,266,829 reported as investment earnings on the Statement of Revenues, Expenses, and Changes in Net Assets—Primary Government, only \$1,264,743 was claimed as an exclusion because \$2,086 of interest income of the Loan Fund is not subject to the expenditure limitation.

Note 3 - The following schedule presents revenues from which exclusions have been claimed for grants and aid from the federal government and contracts with other political subdivisions:

Note 4 - The District budgets scholarships as revenues, therefore, exclusions claimed for tuition and fees include the amount of scholarship allowances reported on the Statement of Revenues, Expenses, and Changes in Net Assets—Primary Government.

Note 5 - Prior years carryforward consists of constitutionally excludable revenues unexpended in the year of receipt that have been accumulated and were expended in the current year as follows:
