We have audited the accompanying Annual Budgeted Expenditure Limitation Report of Maricopa County Community College District for the year ended June 30, 2011. This report is the responsibility of the District's management. Our responsibility is to express an opinion on this report based on our audit.

Note 1 – Summary of Significant Accounting Policies

The Annual Budgeted Expenditure Limitation Report (ABELR) is presented on the basis of accounting prescribed by the uniform expenditure reporting system (UERS), as required by Arizona Revised Statutes (A.R.S.) §41-1279.07, which excludes expenditures of certain revenues specified in the Arizona Constitution, Article IX, §21, from the total budgeted expenditures.

The information reported in both the ABELR and the financial statements is derived from the same underlying accounting data. However, the formats of the ABELR and the financial statements differ. The ABELR presents budgeted expenditures, exclusions, and amounts subject to the limitation by fund type as required by A.R.S. §41-1279.07. The financial statements present the net assets, changes in net assets, and cash flows in accordance with U.S. generally accepted accounting principles.

In accordance with the UERS requirements, a note to the ABELR is presented below for any exclusion reported in the Total column on Part II that cannot be traced directly to an amount reported in the annual financial statements.

- Note 2 Exclusions claimed for debt service requirements on bonded indebtedness and debt service requirements on other long-term obligations are \$92,096,034 and \$26,062, respectively. Both amounts are included in the amounts reported as principal paid on capital debt and leases and interest paid on capital debt and leases on the Statement of Cash Flows—Primary Government.
- Note 3 The amount of \$1,227,634 was reported as investment earnings, net of investment expense on the Statement of Revenues, Expenses, and Changes in Net Assets—Primary Government. The amount of exclusions claimed for dividends, interest, and gains on the sale or redemption of investment securities of \$917,571 is less than the amount reported on the Statement of Revenues, Expenses, and Changes in Net Assets—Primary Government. The difference is explained below:

- Note 5 The exclusions claimed for grants, aid, contributions, or gifts from a private agency, organization, or individual, except amounts received in lieu of taxes consist of amounts expended from private grants and contracts and private gifts reported on the Statement of Revenues, Expenses, and Changes in Net Assets—Primary Government.
- Note 6 The Maricopa County Community College District Governing Board approved the accumulation of \$3,732,034 for the purpose of purchasing land, buildings, or improvements or construction of buildings or improvements. Of this amount, \$1,067,705 was claimed as an exclusion while \$2,664,329 was not eligible to be carried forward under the expenditure limitation requirements.
- Note 7 The District does not budget tuition and fees revenues net of scholarship allowances. Of the gross tuition and fees of \$238,931,566 reported on the Statement of Revenues, Expenses, and Changes in Net Assets—Primary Government, only \$163,287,552 was expended and claimed as an exclusion. Of the remaining balance of \$75,644,014, only \$25,053,863 has been carried forward to future years because \$50,590,151 was not eligible to be carried forward under the expenditure limitation requirements.
- Note 8 Prior years carryforward of \$68,806,766 in the Unexpended Plant Fund consists of constitutionally excludable bond proceeds unexpended in the year of receipt that have been accumulated and were expended in the current year.
