We have audited the accompanying Annual Budgeted Expenditure Limitation Report of Navajo County Community College District for the year ended June 30, 2003. Note 1 - Summary of Significant Accounting Policies

The Annual Budgeted Expenditure Limitation Report (ABELR) is presented on the basis of accounting prescribed by the uniform expenditure reporting system (UERS), as required by Arizona Revised Statutes (A.R.S.) §41-1279.07, which excludes expenditures of certain revenues specified in the Arizona Constitution, Article IX, §21 from the total budgeted expenditures.

The information reported in both the ABELR and the financial statements is derived from the same underlying accounting data. However, the formats of the ABELR and the financial statements differ. The ABELR presents budgeted expenditures, exclusions, and amounts subject to the limitation by fund type as required by A.R.S. §41-1279.07. The financial statements present the net assets, changes in net assets, and cash flows for the District as a whole in accordance with U.S. generally accepted accounting principles.

In accordance with the UERS requirements, a note to the ABELR is presented below for any exclusion reported in the Total column on Part II that cannot be traced directly to an amount reported in the annual financial statements.

- Note 2 Exclusions claimed for debt service requirements on bonded indebtedness and debt service requirements on other long-term obligations are \$1,504,675 and \$251,769, respectively. Both amounts are included in the amounts reported as principal paid on capital debt and interest paid on capital debt on the Statement of Cash Flows.
- Note 3 The amount of \$247,323 was reported as interest and dividends on the Statement of Revenues, Expenses, and Changes in Net Assets. Of this amount, all was claimed as an exclusion for dividends, interest, and gains on the sale or redemption of investment securities, except for \$1,914 recorded in the Endowment Fund and \$57,037, that has been carried forward to future years.
- Note 4 The following schedule presents revenues from which exclusions have been claimed for grants and aid from the federal government and contracts with other political subdivisions:

- Note 5 Of the \$5,822,720 reported as payments made to contractors on the Statement of Cash Flows, \$4,696,072 was expended from amounts authorized and accumulate for the purpose of purchasing land, and purchasing or constructing buildings or improvements and was, therefore, claimed as an exclusion.
- Note 6 The District budgets scholarships as revenues. Of the gross tuition and fees of \$2,318,075 reported on the Statement of Revenues, Expenses, and Changes in Net Assets, only \$424,211 was expended and claimed as an exclusion. The remaining \$1,893,864 has been carried forward to future years.
