Subject: Topock Elementary School District—Still in Noncompliance with the USFR

Dear Members of the State Board:

The Topock Elementary School District (District) has been in noncompliance with the *Uniform System of Financial Records for Arizona School Districts* (USFR) since July 2023 based on our review of the significant deficiencies cited in its audit reports and USFR Compliance Questionnaire (Questionnaire) for the year ended June 30, 2022, and our November 2022 performance audit follow-up report. On January 5, 2024, we notified you that the District was not ready for a status review to determine if it is no longer in noncompliance with the USFR based on assertions in the District's submitted October 2023 corrective action plan and discussions with District management. Further, on April 22, 2024, the State Board of Education directed the Superintendent of Public Instruction to withhold 3 percent of the District's State Aid in accordance with Arizona Revised Statutes §15-272(B).

We received and reviewed the District's financial audit reports and Questionnaire for the year ended June 30, 2023, in July 2024, and issued a December 2024 performance audit follow-up report, which together indicated that the District is still in noncompliance with the USFR. As required, we are providing you a list of the most significant USFR deficiencies we noted in those reports. Further, we have provided the District an updated corrective action plan template to document corrective actions taken to comply with the USFR. In the next several weeks, we will schedule periodic meetings with District management to discuss the specific USFR requirements of each applicable deficiency area and the District's planned corrective actions. When the District can show it has corrected its deficiencies, my Office will perform a status review to determine if the District is no longer in noncompliance with the USFR and we will inform you of the results.
